



Dear Boscoite-Lonavla,

We (Planning Committee and Core Team) had been meeting in the last year to plan for our Institution's Diamond Jubilee.

During the past few months due to the second wave, 5 of the house team got infected with COVID and 2 had to be hospitalised. Relatives of 2, got infected and mother of Bro Jansen left for our heavenly abode. Hence, we just met in this month to take stock of our plans for our celebrations of the Diamond Jubilee.

We have decided to tone down our celebrations due to 2 reasons:

1. The pandemic is still on and expecting a third wave.
2. The institute has suffered a loss of ₹ 96 lakhs due to reduction and non-payment of fees though the teachers full salary was paid in time.

Lonavla is a tourist destination and jobs are majorly dependent on this industry and hospitality has been the worst affected in this pandemic

Hence for the muted celebrations of DJ60, at present it has been decided to continue with the inaugural Mass and prayer service on 15th August and launch of DJ60 anthem and website of our aspirantate and the closing Mass and prayer service online. We can decide later, other festivities as things improve in our country from the pandemic and its effects.

Also, it was decided to help our Alma Mater in getting help and start sponsoring the institute's social development work of giving rations to 137 families in 3 villages around Lonavla. The monthly cost at presently is ₹ 120,000/. During these times we need to assist DBL to support in as much as we can.

We can support by even a proverbial drop in the ocean via UPI or NEFT directly to DBL accounts, it would help. You can send money to this account from your Indian accounts. International donors will have to ask their relatives in India to send to this account.

Once done you can message Fr. Godfrey on WhatsApp (+91 81690 84375) to confirm and get a receipt for tax purposes. This donation is eligible for tax exemption under 80G.

Further, if you have contact with past pupils who have business or some contacts in companies who have CSRs funds and would like to sponsor school fees of the student, they could be approached to get their sponsorship.

The Fee structure is as given after this message. Get sponsors for 1 student or 10 students, for 1 month, 6 months or 1 year or 5 years or 10 years. Any small contribution will help.
